Azerbaijani President: We don't feel any obstacles in terms of the development of our energy projects

"We have never felt any pressure in terms



of the development of our energy projects. I would even say the opposite. Since Azerbaijani gas

will, to a certain extent, ensure the energy security of European countries, we have felt the support of the European Union," said President Ilham Aliyev as he was interviewed by the Russian Rossiya-24 TV channel. "Meetings of the Advisory Council on the implementation of the Southern Gas Corridor project are held in Baku every year. Since several EU member-countries are involved in this project, the European Union is always represented at meetings of the Advisory Council at a high level. We are implementing our energy projects because we need them, because we are a country rich in oil and gas reserves. We need to sell them and earn money. Therefore, we have

attracted investor companies, so we attracted banks, we are building gas and oil pipelines. The Southern Gas Corridor alone costs about \$40 billion. Most of this investment is borrowed capital. Therefore, of course, active cooperation with international financial institutions is an important factor in this project."

The head of state said: "Therefore, in this context, in terms of energy projects, we do not feel any obstacles. On the other hand, you are quite right that the significance and role of Azerbaijan not only in the energy market but also in general, in geopolitical terms, is growing." "The country is becoming more developed, has more plans to assert itself in the region. And in proportion to our development and to how we conduct independent policies, pressure on us is growing. But it is not connected with energy factors, it is connected with attempts to involve us in some adventures that are absolutely alien for our people and our country," the Azerbaijani President added.

#### **SOFAZ** marks its 19th anniversary

Established 19 years ago on December



29. 1999 as successful result of the national oil strategy laid by the national leader Heydar Aliyev, the State Oil Fund of the Republic of Azerbaijan (SOFAZ) aims efficient management of the accumulated oil and gas revenues, and

assignment of these assets to the development of advanced areas and implementation of projects of socio-economic and strategic importance.

During the 19 years of its establishment, SOFAZ has taken significant measures to successfully achieve the defined goals and objectives.

While the total assets of SOFAZ amounted to USD 270 mln at the time of its establishment, in 2018 it has already exceeded USD 38 bln.

Today, based on the efficient asset management principles, SOFAZ finances major national projects of social-economic importance.


According to the strategic decision of national leader Heydar Aliyev, measures on improvement of social conditions of refugees and internally displaced persons are taken at the expense of SOFAZ's assets. Construction of the Baku-Tbilisi-Ceyhan main export pipeline named after Heydar Aliyev, Oghuz-Gabala-Baku water pipeline, Star Oil Refinery Complex, as well as Baku-Tbilisi-Kars new railway regarded as an economically efficient, fast, safe and reliable project initiated by the President of the Republic of Azerbaijan Ilham Aliyev has also been financed by SOFAZ. Moreover, SOFAZ finances the reconstruction of the Samur-Absheron irrigation system.

One of the key projects financed by SOFAZ, in accordance with the Order of President Ilham Aliyev, is the "State Program on education of Azerbaijani youth abroad in the years of 2007-2015". The project aims at transforming "black gold into human capital".

From the day of its establishment, transparency has been one of the crucial principles SOFAZ adheres to and as a result of this, it is the first government agency among organizations of Eastern Europe and CIS countries to be awarded with "United Nations Public Service Award" in May 2007. Additionally, in October 2018 SOFAZ was included in the 'Public Investor 100' Ranking prepared by the Sovereign Wealth Fund Institute (SWFI) and was ranked 10th based on analyses of various dimensions on management of the state-owned assets.

Thanks to all these measures, today SOFAZ is widely acknowledged not only in Azerbaijan but also in the international arena for its institutional capacity building, efficient asset management, transparent operations and openness to information.

#### BP launches newly retro-fitted vessel to be used for acid stimulation activities in selected 17 ACG wells





fine Azeri-Chirag-Gunashli (ACG) field development project recently launched a newly retro-fitted vessel to be used for acid

stimulation activities in selected 17 ACG wells.

This is the first time wells stimulation from a vessel technique will be applied to the Caspian to enhance field production. Historically, this activity was performed from platforms creating challenges including ria equipment availability. additional personnel on board, limited acid volume due to deck space and safety issues related to handling of chemicals. In addition, platform stimulation technique was a time-consuming activity – stimulation of 14 wells has taken two years to complete since 2016.

The retro-fitted vessel – the Caspian Provider, is owned by Topaz and the project was implemented by Baker Hughes, a GE company.

Mike Zanghi, BP's Vice President, Wells, said: "We have been thinking about

optimizing our wells stimulation activity for some time looking at various options. Globally, this operation is performed from fit-for-purpose pumping vessels, however, due to the logistical constraints related to transportation via canals, it has been impossible to bring such a vessel to the Caspian. Therefore, we decided to install the stimulation plant onto one of our service provider vessels relieving our platforms from a resource consuming operation. This is yet another modernization effort for the Caspian which will enable us to further enhance the efficiency of our assets production. including Taking this opportunity, I would like to thank our contractor Baker Hughes, a GE company, for completing this Caspian first project safely and efficiently."

Commissioning activities on the vessel were completed at the end of November with plans to commence the first stimulation operation for the West Azeri platform in mid-December.

ACG currently has six production platforms with a total of 112 producing oil wells and 53 water and gas injection wells. The average daily production rate from the field is currently around 588,000 barrels per day. The field has to date produced 3.5 billion barrels of oil since the start of production in November 1997.

## SOCAR and BP explore creation of a new petrochemicals joint venture in Turkev

BP and SOCAR Turkey today announced



that they have signed a heads of agreement (HoA) to evaluate the creation of a joint venture that would

build and operate a world-scale petrochemicals complex in Turkey.

The proposed facility, in Aliaga in western Turkey, would produce 1.25 million tonnes per annum (tpa) of purified terephthalic acid (PTA), 840,000 tpa paraxylene (PX) and 340,000 tpa benzene. PTA is used to manufacture polyesters, which have many uses including food and beverage

containers, packaging materials, fabrics, films, and other consumer and industry applications.

Following the signing of the HoA, BP and SOCAR Turkey now expect to undertake design work for the facility, which would allow for the integration of feedstock supplies from the nearby new STAR petrochemicals Petkim refinery and complex, both owned by SOCAR Turkey. Vagif Aliyev, Chairman of the Board of SOCAR Turkey, said: "We entered the Turkish market in 2008 with the acquisition of Petkim and since then have realized giant projects such as the STAR refinery. TANAP, Petlim Container Terminal and Petkim Wind Power Station. The area covering all of SOCAR Turkey's projects in Aliaga has recently become the first Private Industrial Zone in Turkey. The immediate the proximity to feedstock infrastructure provided by SOCAR's other facilities will contribute significantly to the competitive power of the new facility. Expanding our immense refining and petrochemical complex, built at the gateway to world markets on the Aegean coast of Turkey, we aim to continue to contribute to the economies of the two brother countries - Turkey and Azerbaijan." Luis Sierra, CEO for BP's global aromatics unit said: "If taken forward, this would be the largest integrated PTA, PX and aromatics complex in the Western Hemisphere and BP's first major new aromatics platform since our Zhuhai site in China opened nearly twenty years ago. The combination of BP's leading proprietary technology and integration with SOCAR's new refinery could create an outstanding platform to serve Turkey's growing polyester packaging and textiles industry. We look forward to drawing on the strengths of both BP and SOCAR to explore the creation of a highly competitive facility."

BP and SOCAR expect to work towards a potential final investment decision in 2019, which could result in start-up of the new plant in 2023.

BP's latest proprietary PTA technology has significantly lower capital and operating

costs when compared with other PTA technologies. It is more energy efficient, uses less water and produces less solid waste than similar technologies on the market.

BP and SOCAR are longstanding partners in a number of major oil and gas production and transportation projects in Azerbaijan, Turkey and the wider region, including the Shah Deniz 2 gas project in Azerbaijan that began production early this year, exporting natural gas to Turkey and beyond.

"This proposed new investment is a 'win-win' situation for both SOCAR and Turkey. It will not only increase our share in Turkey's petrochemical markets, but it will also help to reduce Turkey's imports of these products, hence reducing the foreign trade deficit. All of our projects in Turkey are planned with this goal in mind," said SOCAR Turkey CEO Zaur Gahramanov.

"This potential major new direct investment would be our first equity investment in petrochemicals in Turkey, a country where BP has now been present for over 100 years. Turkey operates as a bridging country between the East and West, and between producers and consumers, and its fast-growing economy offers attractive investment opportunities," said Mick Stump, president of BP Turkey.

# TANAP has pumped 750 million cubic meters of Azerbaijani natural gas to Turkey

"750 million cubic meters of Azerbaijani



natural gas has been delivered to Turkey through the Trans-Anatolian Natural Gas Pipeline (TANAP) so

far," a SOCAR official has told.

Deputy head of the company's public relations department Ibrahim Ahmadov said the total volume of gas pumped through TANAP will be increased to 1 billion cubic meters by the end of 2018. "TANAP is expected to pump 2 billion cubic meters of Azerbaijani natural gas in 2019, 4 billion cubic meters in 2020 and 6 billion cubic meters in 2021."

TANAP aims is to bring natural gas produced from Azerbaijan's Shah Deniz-2 gas field, and other areas of the Caspian Sea, primarily to Turkey, but also on to Europe. TANAP, along with the South Caucasus Pipeline (SCP) and the Trans-Adriatic Pipeline (TAP) form the elements of the Southern Gas Corridor. TANAP's shareholders are SOCAR (51 percent), Turkish firm Botas (30 percent), BP (12 percent) and SOCAR Turkey (7 percent).

experts from the ICAO accredited countries Europe and international aviation agencies. important issues environmental protection in civil aviation will be discussed.

The ICAO EUR ENV PT was established at a joint meeting of the European Air Navigation Planning Group (EANPG COG) European Regional Coordination Group (RCOG), held on May 16-18, 2018, at the ICAO office in Paris.

Azerbaijan's civil aviation expresses the state's policy, which is based environmental priorities and supports the economic development, in its activities, as well as in cooperation with the ICAO, ECAC, CANSO, IATA and other international organizations. It plays a role addressing leading in environmental issues at the regional level. It should be noted that in order to implement **ICAO** General Assembly Resolution A39-3 Consolidated statement of continuing ICAO policies and environmental practices related to protection – Global Market-based Measure (MBM) Scheme, the European Aviation Conference (ECAC) with its 44 including Azerbaijan member states supported The Bratislava Declaration in the context of the CORSIA - Carbon Offsetting

and Reduction Scheme for International Aviation on September 3, 2016. According to the Declaration, starting from 2020, national airlines will be obliged to report to the state aviation authorities about the amount of carbon emissions from their flights. The state aviation authorities in turn will be obliged to submit annual reports to the ICAO.

According to ICAO General Assembly Resolution A39-2, all member states are voluntarily recommended to Emissions Reduction Action Plan and to renew this State Plan every three years.

environmental activities ICAO's undertaken through the aviation technical commission and regional working groups consisting of aviation experts.

Activity in this structure plays a direct role in formation and adoption of new SARPs -Standards and Recommended Practices, research of expert-level solutions implementation of the international requirements on environmental protection, the adoption of relevant decisions and assisting ICAO Member States in this regard.

#### Turkey, Azerbaijan to produce freight cars for BTK rail

Turkey and Azerbaijan will jointly produce



freight cars for the Baku-Tbilisi-Kars railway (BTK), the Turkish transportation and infrastructure minister said on Wednesday.

Anadolu Agency reported.

"Turkey and Azerbaijan will set up a plant in Azerbaijan to produce freight cars for BTK railway," Mehmet Cahit Turhan told reporters after his meeting with Azerbaijan Railways head Javid Gurbanov.

"Work on the project is about to be completed. Factory sites were located for manufacturing. They will be produced immediately after establishing the plants," Turhan noted.

The BTK railway line is only providing freight shipment services, Tuhan said, adding that passenger transportation will start in the coming years.

He said not only Turkey, Azerbaijan and Georgia will benefit from the railway, but also other countries.

The 826-kilometer (513-mile) BTK railway project linking Turkey, Azerbaijan and Georgia began operation last year.

### SOCAR bond prices hit new record highs

SOCAR bonds were sold at their record



price, despite being more than a month till the next coupon payment.

According to the information given by

the "PSG Kapital" – the market maker of SOCAR bonds, trades were realized at price of 1032 USD per bond on December 5th. This is the highest selling price since the issue date.

Heavy demand for bonds is the main driver of price hikes.

SOCAR bonds were issued mainly for domestic market with maturity of 5 years and annual coupon payments of 5%, paid quarterly.

8 coupon payments have been realized in regards of these debt securities so far. The next coupon payment is due on January 12, 2019.

The main advantages of SOCAR bonds are purchase price at their nominal value guaranteed by SOCAR, higher liquidity, easy-to-use operations, and regular interest payments as scheduled.

SOCAR bond holders also benefit from borrowing short and, long-term loans by pledging their bonds while retaining 5% annual coupons incomes.

SOCAR bonds are traded at ASAN Service Center No.1 and No.5.

#### **UNEC, BSE sign MoU on cooperation**

Azerbaijan State University of Economics



(UNEC) and the Baku Stock Exchange (BSE) have signed a Memorandum of

Namazov noted that the fund will support the strengthening of awareness of capital markets and financial systems among students. He also noted that UNEC will play an important role in bringing fundamental knowledge to companies involved in the Listing Program.

Under the Memorandum the special attention will be paid to preparation of joint programs in the direction of education, science, training and the issues related to the expansion of the developmental cooperation between the sides in this area, the exchange of information and the implementation of relevant projects.

In addition, it is planned to hold the trainings and organize the conferences by the specialized experts of UNEC and BSE in accordance with the needs of the companies involved in the Listing Advisory Program of the Baku Stock Exchange.

The BSE will provide the adequate support in obtaining the information on the securities market in order to assist the academic-teaching staff and the students of the master's degree level of study to conduct the scientific researches on the financial markets.

On the sidelines of the event, the Azerbaijani trading house and Polish STX ONE firm signed a MOU on the purchase of hazelnuts and pomegranate juice concentrate from Azerbaijan.

### "Future of broadband mobile internet – 5G and beyond"

The CEO of Azercell Telecom joined the

This year Caspian Innovation Conference was held for the first time as part of the Bakutel-2018, the 24th Azerbaijan International Telecommunications, **Innovations** and High **Technologies** Exhibition and Conference in our country. The conference initiated by the Ministry of Transportation, Communication and High Technologies was devoted to "Digital Connectivity for Sustainable Development" with the view of bridging the digital divide, examining the possibilities of digital connectivity for foreign investment and ensuring business efficiency, has brought together government representatives. industry leaders, officials of regulatory structures and international organizations, including heads of major regional telecommunications and satellite operators.

Vahid Mursaliyev, the CEO of Azercell Telecom LLC, took part as a speaker in the conference aimed to discuss opportunities for effective cooperation between all

participants in the ICT sector, as well as challenges in the relevant field. Pointing out the importance of Caspian Innovation Conference which was arranged in the framework of Bakutel, the important technological event in our country, CEO expressed his gratitude to the Ministry of Transportation, Communication and High Technologies, the main organizer of the event.

Vahid Mursaliyev mentioned "Future of broadband mobile internet – 5G and beyond" and informed the participants about the latest achievements of Azercell in LTE network.

"Currently, our strategy is aimed improving the quality of mobile communications everywhere, expanding 4G network in the regions, introducing advanced services and new business solutions, improving subscriber services, providing the market with affordable mobile devices supporting high-speed Internet and so on, which will help our subscribers to make their lives and work easier through mobile technology. I have to note that since the beginning of this year we have made large investments on technology projects and network," CEO reported. emphasized the fact that Azercell's market share has grown by 1%, reaching a total of 49%. The company has become a leader in the number of new customers joining Azercell network and the number of mobile Internet users in the current year.

CEO shared his opinions about the perspectives network of 5G with participants. He pointed out that the biggest shift in mobile technology to date is already underway, with infrastructure projects happening across the globe. He noted positive changes which promise a step change standard wireless in new communications – higher bandwidth, faster speeds, easy access to the Internet, greater availability and coverage, higher energy efficiency, and crucially, ultra-low latency, (30 times better than 4G) used for mission-critical M2M and IoT applications. "With data-hungry technologies like virtual reality and extended reality around the corner, networks need to be able to
