WORLD ECONOMIC FORUM

President Ilham Aliyev attended "Strategic Outlook: Eurasia" interactive session as part of World Economic Forum

An interactive session on "Strategic



Outlook: Eurasia" has been held in Davos as part of the World Economic Forum. President of the

Republic of Azerbaijan Ilham Aliyev attended the session.

The head of state made a speech at the event and responded to participants' questions.

President of Azerbaijan Ilham Aliyev has stressed the significance of energy projects as he spoke at an interactive session on "Strategic Outlook: Eurasia" as part of the World Economic Forum in Davos. "They are important for us, they are important for the region and the projects, which we initiated, actually change the energy map of the region." "The first pipeline we built to

Georgia, to the port of Supsa connected the Caspian and Black seas. Then, the second pipeline for crude oil from Baku-Tbilisi-Ceyhan connected the Caspian and Mediterranean. Then, on the same route we built a gas pipeline. Therefore, we have already diversified export routes for our hydro-carbons, at the same time, providing substantially energy security of our partners, including those in Europe. Some countries of the European Union get the biggest part of their oil supply from Azerbaijan, and after we successfully complete the Southern Gas Corridor project, in two-three years' time they will also get access to our natural gas," the head of state said.

He also stressed the significance of transportation projects. "Baku-Tbilisi-Kars changed the transportation map of the region. It is now the shortest route from China to Europe, which will take you about two weeks instead of 30-35 days before that. So this is a new map of transportation, the new map of energy diversification, and Azerbaijan being a landlocked country

already managed, I think, to transform into a regional transportation hub. However, we still have to work," President Ilham Aliyev said.

'Extension of ACG contract brings us important dividends', President Ilham Aliyev

'The extension of the Azeri-Chirag-



Gunashli contract also brings us other important dividends', President of Azerbaijan Ilham Aliyev stated at the

meeting of the Cabinet of Ministers on January 10 dedicated to the results of socio-economic development of 2017 and objectives for the future.

The Head of State said that in 2017 historic events took place in the field of energy. 'One of them was the extension until 2050 of the contract for the Azeri-Chirag-Gunashli field. This will allow us the opportunity to maintain our levels of production for many years - at least until 2050. This will make it possible for foreign investors to continue to invest heavily in the oil sector in Azerbaijan. We are talking about tens of billions of dollars. Of course, this investment will have a positive impact on all sectors of our economy. I mean the creation of new jobs and new local enterprises. Of course, maintaining oil production at a stable level will allow us the opportunity to plan our economic development and gradually reduce dependence on oil. In the last two years, we have largely achieved this.

The extension of the Azeri-Chirag-Gunashli contract also brings us other important dividends. First of all, SOCAR's share increases from 11 to 25 per cent. 75 per cent of the profit oil will remain with the Azerbaijani side. I can say that this is an excellent result for а young independent country achieved with foreign investors in the oil sector. The State Oil Company of Azerbaijan (SOCAR), together with other partners, will participate in the project as the operator. For extending the contract, even though foreign investors will invest tens of billions of dollars, an additional bonus of 3.6 billion dollars will be paid in equal instalments over the course of eight years. The first tranche will be provided this year. This, briefly, is the significance of the "Azeri-Chirag-Gunashli" project', the President of Azerbaijan emphasized.

SOCAR to receive AZN100M for gasification

President of Azerbaijan President Ilham



Aliyev has tasked the State Oil Company (SOCAR) to bring the level of gasification up to 95% in 2018.

At the conference devoted to the 4th year of the State Program on Socio-Economic Development of Regions for 2014-2018 President Ilham Aliyev stated that currently the level of gasification is 93% and this is a good indicator.

"But there are still villages where gas lines have not been laid. Our country plans to allocate AZN 100 million to SOCAR for this purpose. Particularly, SOCAR should carry out work on gasification for the short term and bring its level up to 95%. Then, steps will be taken next year to lay the gas lines to the remote villages," the head of state underlined.

SOFAZ receives first bonus payment from Azeri-Chirag-Gunashli Agreement

The State Oil Fund of the Republic of



Azerbaijan (SOFAZ) received the first bonus payment in the amount of USD 450 million from the new Agreement signed among the State Oil Company of the Republic of Azerbaijan

(SOCAR) and foreign extractive industry companies on the "Joint development and production sharing for the Azeri and Chirag fields and the deep water portion of the Gunashli field in the Azerbaijan sector of the Caspian Sea" on January 29, 2018. According to the contract, the foreign investors will pay everall a begus of USD.

According to the contract, the foreign investors will pay overall a bonus of USD 3.6 billion to SOFAZ over the next 8 years. The participants of Azeri-Chirag-Gunashli project are Azerbaijan (ACG) Limited, BP Exploration (Caspian Sea) Ltd., Chevron Khazar Ltd., Exxon Azerbaijan Ltd., Inpex Southwest Caspian Sea Ltd., Itochu Oil Exploration (Azerbaijan) Inc., ONGC

Videsh Ltd., Statoil Apsheron AS. and TPAO.

Buta Airways launches Baku-Sofia direct flight

Azerbaijan's low-cost air carrier Buta



Airways launched direct flight Baku-Sofia-Baku.

Baku-Sofia flights of Buta Airways will serve as a basis for

the development of tourism, business and relations between Azerbaijan and Bulgaria, Director of Buta Airways Jamil Manizade said at a press conference dedicated to the first such flight in Sofia. Jamil Manizade expressed gratitude to the colleagues at the Sofia airport, Bulgaria's Civil Aviation Administration, representatives of the ground handling company who helped to implement this project as soon as possible. "Civil aviation and today's event made the capitals of Azerbaijan and Bulgaria closer. We are very pleased that Buta Airways served as the bridge between the two countries that united, and in the future will serve as an excellent basis for the development of tourism, business and relations between the two states," he said. Bulgaria Azerbaijan's Ambassador to Nargiz Gurbanova noted that Buta Airways is the first low-cost non-EU company to fly to Bulgaria.

"I am convinced that this line will make Azerbaijan and Bulgaria even closer and will strengthen the position of our countries as effective connecting centers for travel," she said.

Addressing the press conference. Bulgarian Minister of Transport, Information **Technologies** Communications Ivaylo Moskovski noted that Azerbaijan and Bulgaria will be able to implement a number of important tourism projects through the launch of a direct flight. "In the end, we achieved the goal that was set in 2015. This result was achieved due to the efforts and will of both sides - the Bulgarian government, Prime Minister Boyko Borisov with the active participation of the President of Bulgaria, as well as the President of Azerbaijan Ilham Aliyev," Moskovski stressed.

He noted that due to the direct airline, countries can count on developing contacts between business circles.

An agreement on opening of direct flights between Baku and Sophia was reached during negotiations of Presidents of Azerbaijan Ilham Aliyev and Bulgaria Rumen Radev.

The minimum fare on route Baku-Sophia, as well as in other routes of airline, will be 29 euros (one way). The flights will be carried out once a week on Tuesdays.

The sale of tickets is open on the official website www.butaairways.az. Being a low-cost airline, the minimum fare Buta Airways will offer additional services such as carriage of baggage, hand luggage, hot meals onboard, check-in at the airport, and seat selection in the airplane on a paid basis.

Buta Airways is the first low-cost airline in Azerbaijan, a structural unit of Azerbaijan Airlines (AZAL). It was founded in December 2016. The Airline's fleet consists of modern Embraer aircrafts. The Airline is based in Baku, at the Heydar Aliyev International Airport.

European Commission allocates 1 million euro for future development of Baku International Sea Trade port

"The European Commission has allocated



1 million euro as part of technical assistance for the future development of the Baku

International Sea

Trade Port," Director-General for Mobility and Transport of the European Commission Henrik Hololei has told reporters.

Henrik Hololei noted that the Baku Port occupies an important place in trade turnover between Europe and Asia, adding that this port and some international corridors crossing through Azerbaijan has turned Azerbaijan into a transit country and a logistics hub.

"Azerbaijan is implementing important projects in this area. The commissioning of the Baku-Tbilisi-Kars railway is a part of these projects."

"The transportation on this alternative route is much quicker and more cost-effective. From this point of view, the role of the Baku Port is particularly noteworthy," Hololei added.

S&P predicts steady growth for Azerbaijan

Standard & Poor's Global Ratings agency



has forecast Azerbaijan's GDP growth to average 3.3% over the next four years, the S&P said in a report.

according to Financial Tribune newspaper. On Jan. 26, the S&P revised its outlook on the long-term foreign and local currency sovereign credit ratings on Azerbaijan to stable from negative. At the same time, the agency affirmed the ratings at 'BB+/B'.

S&P expects Azerbaijan's economy to grow 2.7% in 2018 and 3.5% in 2019, 2020 and 2021. "We expect economic dynamics

to gradually shift over the next few years," the report said. "In particular, we forecast average growth of 3.3% through 2021. Completion is approaching for the large Shah Deniz II gas field project which will see Azerbaijani gas delivered first to Turkey and then to Europe. Elevated investment ahead of the SDII launch and a pickup in gas exports after that should benefit economic performance.

"We have now revised our estimates of State Oil Fund of the Republic of Azerbaijan's liquid assets, excluding from our calculations exposures that might be hard to liquidate in a downside scenario, such as the fund's domestic investments and foreign equity exposures. We estimate last year's general government deficit amounted to 1.5% of GDP," the report said. Azerbaijan's nominal GDP will continue to grow and by 2021 will increase from 70 billion manats (\$41 billion) to 99 billion manats (\$52 billion), the report noted.

According to S&P analysts, GDP per capita will be \$4,600 in Azerbaijan in 2018, \$4,800 in 2019, \$5,000 in 2020 and \$5,100 in 2021.

The agency also expects inflation rate to fall in Azerbaijan to 5% by 2021. The S&P forecasts 8% inflation in 2018 and 5% in the next three years.

Azerbaijan to open Trade House in Kyiv in March

Azerbaijan will open its Trade House in



Kyiv in mid-March this year, said Azerbaijan's Ambassador to Ukraine Azer Khudiyev in an

interview with Ukrinform.

Azer Khudiyev emphasized that Azerbaijan and Ukraine intend to increase trade turnover up to \$1 billion in 2018.

"In mid-March we are planning to open Azerbaijan's Trade House in Kyiv. We have already found premises in the center of Kyiv, and now the matter is in the stage of documentation. Respective repairs are being conducted simultaneously," Khudiyev said.

According to him, the head of the Trade House has already been elected, and he is currently engaged in the formation of his apparatus. "The Trade House will showcase and sell products of domestic production, as well as coordinate imports,

exports and re-exports. We also plan to analyze the market, identify priority areas of cooperation, and provide legal support for Azerbaijani business companies," the ambassador said. "I am sure that this will be a good platform not only for Azerbaijani business, but also for the development of Ukrainian business. Ukraine has many interesting products and projects, which Central Asian and Iranian markets need to import and export. But this is not possible for a number of reasons. I think that these opportunities can be realized through Azerbaijan and the newly opened Baku Port". International Sea Trade Azerbaijani ambassador added.
