# Shah Deniz celebrates 100 billion cubic metres of total gas production

The milestone was achieved at the end of



December, exactly 12 years after we first announced the start-up of commercial gas

production from the field and start-up of operations of the South Caucasus Pipeline.

First production from the field announced on 15 December 2006 marked the start of Stage 1 of the field development and since then gas has been successfully and reliably delivered to markets in Azerbaijan, Georgia and Turkey.

2018 was destined to become the next biggest milestone year for Shah Deniz. It marked the commencement of commercial gas deliveries to Turkey from Shah Deniz 2 as planned on 30 June and the achievement of first gas production from Shah Deniz Bravo at the end of July.

Total condensate production from Shah Deniz since 2006 is over 196 million barrels.

Today production is received from about 10 SDA and 6 SDB wells.

Shah Deniz – located in the Azerbaijan sector of the Caspian Sea is the largest ever gas discovery made by BP. The giant field covers approximately 860 square kilometres. The field was discovered in 1999.

The estimation of gas initially in place of the whole Shah Deniz field is over 1 trillion cubic metres and 2 billion barrels of condensate.

Shah Deniz 2 is the starting point of the new Southern Gas Corridor, which will deliver Caspian resources directly to European gas markets for the first time. At plateau, the project is expected to add 16 billion cubic meters of gas per year (bcma) to the existing production. Total

production from the Shah Deniz field will be up to 26 bcma of gas and up to 120,000 barrels of condensate a day. Shah Deniz 2 represents the first subsea field development in the Caspian Sea the largest and most complex subsea infrastructure which BP operates in the world.

# Azerbaijan exports more than 2.5 bcm of natural gas to Georgia in 2018

Azerbaijan exported more than 2.5



billion cubic meters of natural gas to Georgia in 2018, according to the Ministry of

Energy.

More than 1.1 billion cubic meters of gas was pumped through the Baku-Tbilisi-Erzurum pipeline, while 1.39 billion cubic meters of gas was transported via Gazimammad-Gazakh pipeline.

#### Baku to host Fifth Ministerial Meeting of Southern Gas Corridor Advisory Council on February 20

The Fifth Ministerial Meeting of the



Southern Gas Corridor (SGC) Advisory Council will take place in Baku on February

20, spokeswoman of Azerbaijan's Energy Ministry Zamina Aliyeva told.

The meeting will be attended by representatives from the Southern Gas Corridor member-states and other countries, shareholders of the project and delegates of international financial institutions.

The First Ministerial Meeting of the SGC Advisory Council was held on February 12, 2015, the second meeting on February 29, 2016, the third meeting on February 23, 2017 and the fourth meeting on February 15, 2018.

## Next OPEC meetings due in Baku in March

"The Joint OPEC and non-OPEC



Ministerial Monitoring Committee (JMMC), as well as the Joint Technical Committee

will convene on 17-18 March in Baku," the OPEC Secretary General Mohammad Barkindo has told in an exclusive interview.

The meetings will review the oil-producing countries' commitment to the agreement on reducing the oil output and its impacts on the oil market.

The 5th **OPEC** and non-OPEC Meeting, Ministerial following deliberations on the immediate oil market prospects and in view of a growing imbalance between global oil supply and demand in 2019, hereby decided to adjust the overall production by 1.2 mb/d, effective as of January 2019 for an initial period of six months. The contributions from OPEC and the voluntary contributions from non-OPEC participating countries of the 'Declaration of Cooperation' will correspond to 0.8 mb/d (2.5%), and 0.4 mb/d (2.0%), respectively. According to the agreement, Azerbaijan has also pledged to reduce oil production by approximately 20,000 barrels per day beginning this month.

Azerbaijani Ambassador in Islamabad Ali Alizade has met with Pakistani Federal Minister for Petroleum Ghulam Sarwar Khan to discuss cooperation between the two countries in the field of energy.



They agreed that Pakistani oil and gas companies' participation in the "Caspian Oil and Gas" exhibition and conference traditionally held in Baku would the bilateral energy

strengthen cooperation.

They also exchanged views over prospects for economic and trade relations between Azerbaijan and Pakistan.

# **Heydar Aliyev International Airport** sets a new record for passenger traffic

Heydar Aliyev International Airport has



set a new record for passenger traffic volume last year it served a total of 4.43

million passengers. This is 9 percent higher than in 2017.

In 2018, base airlines of the Airport - AZAL and Buta Airways carried 1.89 million and 442,000 passengers, respectively.

A total of 3,81 million passengers were carried on international flights and 620,000 passengers on regional flights.

33.4 percent of total number of international passengers accounted for AZAL, while 11.6 percent for Buta Airways, and 55 percent for international airlines.

In addition to AZAL and Buta Airways carrying out international passenger flights in 2018, the top ten airlines also included Turkish Airlines, FlyDubai, Aeroflot, UIA (International Airlines of Ukraine), Air Arabia, S7 Airlines, Qatar Airways, Utair, Lufthansa and SCAT. In

total they served 1.15 million passengers.

The top ten most popular international destinations in 2018 included Istanbul, Moscow, Dubai, Kiev, Sharjah, Tehran, Baghdad, Tbilisi, Doha and Tel Aviv. Some 2.7 million passengers traveled to these destinations.

In total, last year 36 foreign passenger airlines carried out regular flights to Heydar Aliyev International Airport.

Heydar Aliyev International Airport is the largest airport in Azerbaijan and the region in terms of passenger and freight traffic, the airport terminal area and capacity of the cargo complex.

In 2017 and 2018 Heydar Aliyev International Airport was also named the best airport among airports of Russia and CIS countries for the level of the provided services for the second year in a row and awarded the maximum rating of "5 Stars" according to Skytrax World Airport Awards.

# Next coupon payments on SOCAR bonds paid

The 9th coupon payment of SOCAR



bonds with annual yield of 5% and quarterly payments has been executed.

totalling the income of bondholders up to 11 million 250 thousand USD. In the upcoming quarters 11 coupon payments are still outstanding as income for the bondholders with amount totalling to 13 million 750 thousand USD (grand total of 25 million USD).

According to "SOCAR Capital", coupons on SOCAR bonds totalling \$1.25 mln - \$12.5 per bond has been

transferred to the bank account of the National Depository Centre (NDC) at the Central Bank one week earlier, and today these funds will be available in the bondholders' bank accounts.

The main advantages of SOCAR bonds are repurchase guarantee by SOCAR at the nominal amount, simple sale and purchase transactions, payment coupons on timely basis and high liquidity. The secondary market transactions on SOCAR bonds have exceeded amount of 170 million USD since the emission and currently it is the security with highest liquidity in the local stock exchange with over 800 trades executed in 2018. Due to high demand, the market maker prices have risen to 1045 USD per bond on January 16th.

SOCAR bonds, which can be purchased from ASAN Service Centers No. 1 and 5, make up 24% of the total share of the country's total bond market and 87% of the corporate bond market.

Next coupon payments will be executed on April 17th, it was reported.

#### Minister Mustafayev: Republic of Korea invested almost USD 180 million in Azerbaijan's economy

"The Republic of Korea has invested



almost USD 180 million in Azerbaijan's economy, while the Azerbaijani investments to this country amounted to USD

474 million," said Minister of Economy Shahin Mustafayev.

Mustafayev said that a legal framework was established between the two countries, and 57 documents had been signed so far. He mentioned that 74 Korean companies were registered in Azerbaijan, which are also involved in state-funded projects as contractors.

Minister Mustafayev hailed the expansion of economic ties between the two countries, adding that the trade has increased twice in the 11 months of 2018 than of the same period of previous year.
