SOFAZ hosts "Impact Investing: Opportunities and challenges for institutional investors" conference

Organized within the celebration framework of the anniversary of SOFAZ, the conference pinpoint the most recent developments in the impact market and investment environment, and the possible challenges and opportunities.

Over the last decade, impact investing has gained increasing interest and traction within the financial sector. Impact investing enables institutional investors to generate measurable positive social and

environmental impacts alongside a riskadjusted return.

The conference consists of 6 sessions, which aim to solidify the definition of impact investing among institutional investors, potential future scale of impact investing, including evolving markets and products in this area, measurement and reporting tools, the role of sound government policy framework in the future of this industry, as well as climate change transitions.

CEO of SOFAZ Shahmar Movsumov highlighted the significance of impact investing and commented: "As a long term investor, we strongly believe both value creation and sustainability have to be the major cornerstones of our investment strategies and in this regard impact investing has a great potential to achieve both of these objectives. Azerbaijan becomes connecting hub for European air transit flows

Members of the European Organization for the Safety of Air Navigation



(EUROCONTROL) and the Civil Air Navigation Services Organization (CANSO) have met in Brussels.

Azerbaijan was represented in this meeting by Director of "Azeraeronavigation" Air Traffic Control (AZANS) Farhan Guliyev. As part of a working visit, Farhan Gulivev Director met with General of **EUROCONTROL** Eamonn Brennan. During the meeting key issues in the field of air traffic management and planning of overflights through the territory Azerbaijan, as well as the role of the as a strategic partner for Eurocontrol were discussed.

Issues related to the planning of air traffic flows and contingency planning in case of unforeseen circumstances in the region were also discussed.

Eamonn Brennan highly assessed the achievements in field of civil aviation in Azerbaijan and noted that the strategic location and high level of air navigation services provision makes Azerbaijan attractive for the European organization in the field of air traffic flow planning and it increases the number of transit flights between Europe and Asia. Eamonn pointed out that Azerbaijan is a key flight corridor between Europe and Asia.

Following the negotiations, an agreement was signed on the use of the ASEC Center at Heydar Aliyev International Airport for planning, forecasting and interaction in managing of air traffic flows in cases of unforeseen circumstances in the region. The document was signed by AZANS Director Farhan Guliyev and Director of the Network Management Directorate (NMOC EUROCONTROL) Jacopo Prissinotti.

Thus, Azerbaijan has gained high confidence and is recognized as a partner of EUROCONTROL in the planning of

transit flights and the Support center in case of crisis.

AZANS is structural subdivision of Azerbaijan Airlines. The main objectives of the company's operations are to ensure flight safety, as well as service and coordination of air traffic over the territory of the country.

EUROCONTROL is the European Organization for the Safety of Air Navigation, founded in 1960. It has as its primary objective the development of a seamless, pan-European Air Traffic Management system. EUROCONTROL has 41 member states.

Azerbaijan to host NASA Space Apps Challenge for first time

The world's biggest hackathon-NASA



Space Apps Challenge will be for the first time organized in Azerbaijan.

Co-organized

by Azercosmos OJSC and the Embassy in Azerbaijan, in partnership with Azerbaijan Diplomatic Academy (ADA) and the National Agency for Aeronautics and Space Research (NASA), the event will be held on October 18-20 at ADA University. Since its inception in 2012, NASA's International Space Apps Challenge has world's largest become the hackathon, engaging thousands of citizens across the globe to use NASA's open data to build innovative solutions to challenges we face on Earth and in space.

Space Apps inspires local communities to come together, think intensely, and create solutions to important problems. Each year, Space Apps engages thousands of individuals in cities around the world to work with NASA's open source data in a 48-hour sprint. Teams of technologists, scientists, designers, entrepreneurs, artists, and others collaborate to answer some of the most pressing challenges on Earth and in space.

The challenges change each year within the theme of Earth and Space. Some of the most popular challenges last years subjects from included ranging autonomous spacecraft inspection, to monitoring disasters, to exploring the beauty of the Universe.

Challenges of Space Apps 2019 will be announced after September 25. Each participating team will be allowed to work only on one challenge and can start the actual work only at the hackathon itself.

At the end of the last day of the hackathon, teams will take turns presenting their

projects to the judges. Each team presentation should be short (4 minutes each and 2 minutes for answering jury questions). The presentation is the opportunity for each team to highlight its work for the judges to see.
