Interview with colleague Dr. Paez for the purpose of truth

On August 7th, Dr. Jimmy Alberto Pàez Giret gave an interview [for Eurasia Hoy Journal published in the United States, Spanish Language](#). The following is a summary of his interview published in English Version. Dr. JIMMY ALBERTO PÀEZ GIRET, a lawyer graduated from two Paraguayan (Catholic University) and German (Freiburg) Universities with a Physical Problem by Birth, Congenital Scoliosis and with a great discipline and dedication to Scholarly research and Academic Improvement, has studied all his life despite of that Physical Problem.

1. What is the Origin and Meaning of the Expression Devil's Advocate or Attorney?

JIMMY ALBERTO PÀEZ GIRET (JAP): Devil's Lawyers are those Lawyers who defend positions that are contrary to the interests of someone or several individuals who, knowing that it may not be in the good use of reason, present evidence and logical arguments that give validity to their conclusions, against impunity and organized crime. The Catholic Church through Pope Sixtus V gave the Origin to this Expression; it has created it in the year 1587 due to a process of a candidate for canonization or beatification who should have presented proofs and logical arguments to be accepted for his sanctification process. Pope John Paul II in 1983 has ratified this Fact.

As a lawyer I graduated from two Paraguayan (Catholic University) and German

(Freiburg) Universities with a Physical Problem by Birth, Congenital Scoliosis and with a great discipline and dedication to Scholarly research and Academic Improvement, have studied all my life despite of that Physical Problem. First, I completed the High School at the *Colegio San Josè* with several Honorable Mentions. References and Witnesses are sufficient among them: Bishop Ignacio Gogorza, former Director of Colegio San Josè. All of these documents as Proofs of my Impeccable Academic Preparation for more than 30 years are in the Green Box and I can show to all interested parties. I got to work in a hardware store during the 5th year of San Jose High School to buy my books and successfully complete the High School education. In other words, my Physical Problem was never an Obstacle but a Motivation to BE SOMEONE IN LIFE in HONOR TO MY GRANDMOTHER AND MY FAMILY who have always supported me.

In the Faculty of Law and Diplomatic Sciences of the Catholic University *Nuestra Señora de la Asunción*. I have also stood out until reaching the Title of Lawyer and before completing this university experience the Grand Master Cèsar Garay then Minister of the Supreme Court of Justice when I requested guidance to win a scholarship to study in Germany? He replied that I could never win it because it is too high a level for me and my efforts would be in vain. But Dr. Enrique Sosa then Minister of the Supreme Court of Justice realized my desire for overcoming, for that reason he referred me together with Dean Velazquez and Chancellor Tellechea and Judge Bogarìn to apply for the Scholarship to Germany And I showed him my Sacrifice by taking the bus every week to study German language and show to Garay that he was wrong and I won the Scholarship as the best law student in Americas and one of the best in the World in 2001 as I can prove with the Grant Document awarding me a scholarship. I once again emphasize that my Physical Problem was not an Obstacle and I was in Germany studying until I reached the maximum Academic Degree of Master of Laws equivalent to the Doctorate in Paraguay according to the Translation of my Degree in Paraguay.

In other words, I HAVE PROVED beyond any reasonable doubt that I am Dr. Paez Giret, I meet the Requirements so that my Denomination as a Devil's Advocate and investigator does not make me a nor have mental problems. I am neither satanic. I am a CATHOLIC by religion and have put into practice God and I am an INTERNATIONAL OUTSTANDING scholar.

In Germany, for Merits and for my impeccable behavior, I joined the Elite Order of Students, I led several groups of Foreigners and the German Government supported all my Higher Studies and there I was decorated by the Grand Professors and Doctors Claus Roxin Munich and Hans Heinrich Jescheck of the Max Plank Institut and Uni Freiburg in accordance with the Documents that I can provide.

What are the mistakes you have made so that Grand Masters of the Symbolic Lodge of the Masonic Fraternity would take away your practice rights in law and prohibit you from exercising your profession?

JAP: I have denounced several Magistrates of the Judicial Power with Documents, including Ruben Riquelme, Delio Vera Navarro and Jose Waldir Servin, for example, among others. All complaints were based on authentic documents that show serious harm and consequences inflicted against my person and my clients who are not part of nepotism, do not pay bribes and are not part of the Clan within the Symbolic Lodge of Paraguay that is ruling the Judicial Branch of Power in my country.

In 2018, by a high-level Masonic political movement, Dr. Christian Kriskovich was appointed as President of the JEM (a committee in charge of auditing and investigating national judges) after the mega scandal of Oscar [Gonzalez](#) Daher (OGD), the Attorney Kriskovich was desperate to have the support of the Supreme Court of Justice – Paraguay, especially from Dr. ALBERTO JOAQUÍN MARTÍNEZ SIMÓN who was at that time a Member of the Court of Appeals, sixth jurisdiction, where it was to be decided whether the expertise of a Cellular phone owned by the Student who had denounced the attorney Kriskovich for Sexual Harassment, was procedurally correct or not in such a nasty way so that the Criminal Investigation [against Kriskovich] is closed accordingly and Kriskovich's Civil Damages Lawsuit would be opened against his former student.

In that year Mr. Torres Kirmser was the President of the Supreme Court of Justice of Paraguay, together with Minister Bareiro de Mòdica, they were also members of the JEM (Jurado de Enjuiciamiento de Magistrados), in charge of investigating national Judges for wrongdoing.

At the end of 2019 a routine visit is made apparently between all of the Members

of the JEM and the Ministers of the Supreme Court of Paraguay (CSJ) was to supposedly adjust punishment details to prosecute Magistrates – Judges, but in reality the Objective was to finally agree on the supposed future and Political Appeal in the JEM towards myself Dr. Pàez (JIMMY ALBERTO PÀEZ GIRET) for going Against the nasty interests of the JEM and the Judicial Branch in Asuncion, that is, to make transparent and show the real face of some Magistrates that are Members of the Symbolic Grand Lodge of Paraguay.

On December 2019, is issued the Resolution of the JEM and the Warning for Dr Pàez Giret is published and in turn the JEM orders the CSJ to include in my file this Political Sanction knowing that the JEM does not have the prerogatives of the Superintendent Council and on that date was not issued any single official note, nor statement from the Superintendent Council in the CSJ. That is to say, the Cassation was never previously founded on the Warning of the Superintendent Council inside the Supreme Court of Paraguay (CSJ) but it occurred due to supposed Corporate Revenge.

A summary of the Administrative resolution (C. S. C. S. J.) No. 241 of date August 20, 2020

Considering: 1 Paragraph: The Manual of Administrative Procedures approves a maximum date of 3 months to complete a Complaint; The CSJ Superintendent Council confesses that the Complaint was ordered by November 15, 2018 and instructed 2 years later by Resolution No. 834 of July 15th, 2020 or is already expired and prescribed outside the same Administrative Regulation and procedural civil law.

Date of the Event: July 3rd, 2018. Plaintiff: Dr. Arnaldo Martínez Prieto Member of the Symbolic Lodge – Paraguay, Member of the Chamber of Appeals in Civil and Commercial Matters 3rd Chamber in conjunction with Minister Torres Kirmser (Grand Master of the same Symbolic Lodge). ... with the following assertion: it does not agree with the parameters of regularity ... which by altering the processing of the case, deprives the magistrate from a clear vision of the problem ... irreversibly compromises the right of those represented. With the statement of

Manifestation of the Appellant Diana Sacherlardi and her Witness Statement the opposite is demonstrated, but for reasons of going against the Interests of the Grand Masters of the Symbolic Lodge it was considered as Impertinent ... It should be remembered that Mr. Martínez Prieto's impulse was that due to massive Inhibitions he did not know what to do with the Document titled: "Alicia Pucheta de Correa and Others on Lies".

The Analyst of the Superintendent Council states: that the challenge has prevented the normal continuation of the process therefore there are supposedly indications of the execution of the administrative offense On several occasions the Magistrates in animosity and in FOURTEEN cases have alleged and mentioned complaints before the JEM, before the Attorney General's Office and even before the civil jurisdiction for damages ... This implies lack of decorum of the Attorney Páez ... I put on record that the statement of Manifestations and the Witness' Statement is demonstrated that due to mistrust of Mrs. Diana Sacherlardi she has recused with my Sponsorship and without revoking my Sponsorship due to Hatred manifests the Chamber members have inhibited in a series my rights ... but the Analyst did not specify that it was Mrs. Diana Sacherlardi who challenged the system.
