

**No:165/20, Press Release of the Press Service Department
of the Ministry of Foreign Affairs of the Republic of Azerbaijan**

On July 14, 2020, Azizov Aziz Izzet, born in 1944, a resident of Aghdam village of Tovuz region, was killed as a result of artillery fire opened by the Armenian armed forces in the direction of Tovuz region of Azerbaijan.

The purposeful targeting of the Azerbaijani civilian population and shooting by using heavy weapons by Armenia is a clear manifestation of fascism and barbarism. This is part of Armenia's aggressive policy. The murder of an Azerbaijani civilian is a bloody crime.

The Armenian side has previously while purposefully targeting Azerbaijani civilians committed crimes against humanity. 613 civilians in Khojaly were brutally killed on February 26, 1992, the deliberate targeting by the enemy of Azerbaijani civilians, including children, living along the border and near the line of contact, as well as the killing of 6 civilians and the wounding of 33 people during the April 2016 war were innocent victims of the Armenian aggression.

The Armenian armed forces, besides continuously shelling Azerbaijani settlements by using heavy weapons, also cause serious damage to the economy, property and infrastructure of the population.

By such actions, Armenia grossly violates international humanitarian law, including the 1949 Geneva Conventions and its commitments in this regard.

We call on the international community to express a firm position towards the targeting of the Azerbaijani civilian population by Armenian military units and to the fact that Azerbaijani civilians are victims of Armenia's deliberate bloody provocation and to condemn these illegal actions of Armenia.

The political and military leadership of Armenia is fully responsible for the murder of an Azerbaijani civilian.

Četnaestog jula 2020. godine, usled artiljerijske paljbe kojusu jermenske oružane snage otvorile u pravcu oblasti Tovuz u Azerbejdžanu, ubijen je stanovnik sela Agdam, oblast Tovuz, Azizov Aziz Izzet oglu, rođen 1944. godine.

Svesno ciljanje na azerbejdžanske civile iz artiljerijskog oruđajasan je dokaz fašizma i varvarstva. Ovo je deo okupacione politike Jermenije. Jermenska strana je i ranije svesno ubijala mirne žitelje vršeći zločine protivčovečnosti. Brutalno ubistvo 613 civila, uključujući decu koja su živelauz kontaktnu liniju trupa u Hodžaliju, 26.februara 1992. godine, kao i šest ubijenih i 33 ranjena civila tokom aprilskih bitaka 2016., nevine su žrtve jermenske agresije: „Pored toga što jermenske oružane snage stalno obasipaju paljboom naselja iz teškog oruđa, nanose i ozbiljnu štetu ekonomiji i imovinstanovništva, kao i infrastrukturi naselja.

Takvim akcijama Jermenija grubo krši međunarodno pravo, uključujući Ženevske konvencije iz 1949. godine. Azerbejdžan poziva međunarodnu zajednicu da oštro reaguje na činjenicu ciljanog granatiranja mirnog azerbejdžanskog stanovništva od strane jermenskih oružanih snaga i pretvaranja azerbejdžanskih civila u žrtve krvavih zločina, kao i da osudi ove nezakonite akcije Jermenije.

Odgovornost za ubistvo mirnog azerbejdžanskog civila leži na političkom i vojnom rukovodstvu Jermenije.
